

## **Terms and Conditions**

### **Agreement between User and inspireddying.com**

Welcome to inspireddying.com. The inspireddying.com website (the "Site") is comprised of various web pages operated by Amy Rush, Inspired Dying LLC ("Inspired Dying"). inspireddying.com is offered to you conditioned on your acceptance without modification of the terms, conditions, and notices contained herein (the "Terms"). Your use of inspireddying.com constitutes your agreement to all such Terms. Please read these terms carefully, and keep a copy of them for your reference.

inspireddying.com is an E-Commerce Site.

I am a death doula who offers private sessions, in person and virtual classes, and digital downloads that educate and inspire.

### **Electronic Communications**

Visiting inspireddying.com or sending emails to Inspired Dying constitutes electronic communications. You consent to receive electronic communications and you agree that all agreements, notices, disclosures and other communications that we provide to you electronically, via email and on the Site, satisfy any legal requirement that such communications be in writing.

### **Children Under Thirteen**

Inspired Dying does not knowingly collect, either online or offline, personal information from persons under the age of thirteen. If you are under 18, you may use inspireddying.com only with permission of a parent or guardian.

### **Cancellation/Refund Policy**

Appointments require prepayment in full. You may cancel your appointment up to 24 hours in advance for a refund minus PayPal's mandatory 3% transaction fees. Cancellations made within 24 hours will incur a charge of 50% of the cost of the service booked plus PayPal's mandatory 3% transaction fees. Amy Rush/Inspired Dying LLC reserves the right to cancel client appointments at any time for any reason, in which case you will incur no penalties or fees and be fully refunded any prepayment made.

### **International Users**

The Service is controlled, operated and administered by Inspired Dying from our offices within the USA. If you access the Service from a location outside the USA, you are responsible for compliance with all local laws. ### **Indemnification**

### **Arbitration**

In the event the parties are not able to resolve any dispute between them arising out of or concerning these Terms and Conditions, or any provisions hereof, whether in contract, tort, or otherwise at law or in equity for damages or any other relief, then such dispute shall be resolved only by final and binding arbitration pursuant to the Federal Arbitration Act, conducted by a single neutral arbitrator and administered by the American Arbitration Association, or a similar arbitration service selected by the parties, in a location mutually agreed upon by the parties. The arbitrator's award shall be final, and judgment may be entered upon it in any court having jurisdiction. In the event that any legal or equitable action, proceeding or arbitration arises out of or concerns these Terms and Conditions, the prevailing party shall be entitled to recover its costs and reasonable attorney's fees. The parties agree to arbitrate all disputes and claims in regards to these Terms and Conditions or any disputes arising as a result of these Terms and Conditions, whether directly or indirectly, including Tort claims that are a result of these Terms and Conditions. The parties agree that the Federal Arbitration Act governs the interpretation and enforcement of this provision. The entire dispute, including the scope and enforceability of this arbitration provision shall be determined by the Arbitrator. This arbitration provision shall survive the termination of these Terms and Conditions.

### **Class Action Waiver**

Any arbitration under these Terms and Conditions will take place on an individual basis; class arbitrations and class/representative/collective actions are not permitted. THE PARTIES AGREE THAT A PARTY MAY BRING CLAIMS AGAINST THE OTHER ONLY IN EACH'S INDIVIDUAL CAPACITY, AND NOT AS A PLAINTIFF OR CLASS MEMBER IN ANY PUTATIVE CLASS, COLLECTIVE AND/ OR REPRESENTATIVE PROCEEDING, SUCH AS IN THE FORM OF A PRIVATE ATTORNEY GENERAL ACTION AGAINST THE OTHER. Further, unless both you and Inspired Dying agree otherwise, the arbitrator may not consolidate more than one person's claims, and may not otherwise preside over any form of a representative or class proceeding.
